

MONEY BACK GUARANTEE PROGRAM

To qualify for the Money Back Guarantee Program, a student must meet ALL of the following requirements:

- I. Student must register and pay full tuition (less applicable scholarships and discounts) for the entire four part live classroom course. Students enrolled in Home Study Course or signed up for selected parts only may not participate in the money back guarantee program, but may qualify for a free repeat of the course if requirements IV and V are met.
- II. Student must attend ALL 28 live lectures signing attendance sheets at the end of each lecture. A maximum of one missed lecture per part may be made up by home study make up. Students not able to meet this requirement may still qualify for a free repeat of the course if requirements IV and V are met.
- III. Students must finish all 28 live lectures within one year of the start of their first part.
- IV. Student must schedule and take FARE exam within three weeks after last FARE class. Schedule and take Audit exam within three weeks after last Audit class. Schedule and take Regulation exam within three weeks after last Regulation class. Schedule and take BEC exam within three weeks after last BEC class.
- V. Student must backup homework statistics and burn on CD-ROM (see settings section in user guide pg.9.) CD-ROM must show that the student answered all of the multiple choice questions correctly one time and spent a minimum of one minute per question. CD-ROM must also show that the student achieved 75% or more correct on the student's last attempt at the final exam(s). CD-ROM with FARE statistics must be sent to us no later than 28 days from the last FARE class. CD-ROM with Audit statistics must be sent to us no later than 28 days from the last Audit class. CD-ROM with Regulation statistics must be sent to us no later than 28 days from the last Regulation class. CD-ROM with BEC statistics must be sent to us no later than 28 days from the last BEC class. CD-ROM for each part must be sent by certified mail to P.O. Box 300, Solebury, PA 18963.
- VI. If the student fails all four parts of the CPA exam and would like to claim a refund of tuition, the student must send a notarized copy of his/her official grades to P.O. Box 300, Solebury, PA 18963. The official grades must be sent by certified mail within ten days of the student's receipt of the grade for the fourth and final part taken.
- VII. If all six requirements are met, a student may choose either a free repeat of the entire course or a refund of tuition calculated as follows:
- VIII.

Entire course tuition.....	\$2,685.00
Less textbook charge (student keeps).....	(160.00)
Less software charge (student keeps).....	(795.00)

Refund.....	\$1,730.00

If the student passes one or more parts of the CPA exam and has met all six Requirements, no refund will be given, but the student has earned a free Repeat of the course for all remaining parts
- IX. Students registered for our Home Study courses or registered for selected parts of our live review are not eligible for the money back guarantee program. However, these students may qualify for a free repeat of the course if requirements IV and V are met.
- X. Students not meeting money back guarantee or free repeat requirements are entitled to repeat any part of the course or repeat the entire course for 50% of the regular tuition.
